Minutes of Annual General Body Meeting held on October 25, 2024 at Nagash Hall, Serena Hotel, Faisalabad

Number of Participants: A total of 49 members, including all the 7 members of the Executive Council.

- 1. **Opening Remarks and Welcom**e: The meeting commenced at 1800 hours with a warm welcome from the President, acknowledging the presence of members and guests.
- 2. **Approval of Previous Minutes:** The draft minutes of the previous General Body Meeting held on 20 October 2023 were presented and approved by the members.
- 3. **PSNM Activities Report:** The General Secretary provided an overview of the society's activities and achievements since the last meeting.
- 4. **Financial Report:** The Finance Secretary presented the financial report, highlighting the income, expenditures, and the overall financial health of the society.
- 5. **Membership Update:** The General Secretary briefed the members on the current active membership status.
- 6. Establishment of Standing Committees: The members approved the establishment of Standing Committees by President PSNM to support the society's objectives and enhance its role in nuclear medicine. The approved committees include:

- 7. **Website Upgradation:** A proposal to upgrade the society's website to a dynamic module with a user content management system was approved. This upgrade aims to enhance accessibility, member engagement, and content management.
- 8. Introduction of President-Elect and Immediate Past President Positions: A proposal to introduce the positions of President-Elect and Immediate Past President within the Executive Council was presented, with an intent to promote continuity of leadership and ensure sustained progress in society initiatives. It was decided that a committee comprising of former presidents of society will be formed to assess the need, structure, and modalities of these new roles.
- 9. **Adjournment:** The meeting was adjourned at 1900 hours, with the President thanking all participants for their contributions and commitment to advancing the society's mission.
